Press Release - Presidential Statement

In reference to the singer Madonna allegations. Let's be clear, if the allegations are true, we totally stand against such an egregious crime perpetrated upon our black children. However, THE ETHIOPIAN WORLD FEDERATION, INCORPORATED HAS NOT MADE ANY STATEMENT OR CALL FOR ANY INVESTIGATION ON THIS MATTER.

For THE ETHIOPIAN WORLD FEDERATION, INCORPORATED is a Constitutional governmental body whose members/citizens have voting rights. So therefore, in this matter all the members of THE ETHIOPIAN WORLD FEDERATION, INCORPORATED were never given any opportunity of a vote to enter into a legal agreement.

Therefore, notice is given to cease and desist in using THE ETHIOPIAN WORLD FEDERATION, INCORPORATED for it is constitutionally required that each member must be given a vote in all matters. Consequently, no member or nonmember or relative or spouse of a member may take the name of THE ETHIOPIAN WORLD FEDERATION, INCORPORATED and use it as they will. Thus, I am constitutionally required as the Executive Head of THE ETHIOPIAN WORLD FEDERATION, INCORPORATED to give this statement.

Let it be known that this statement has no bearing on the accusations against Madonna, and we stand with the Malawi Government concerning this matter.
